 - Huff: Financial Education Teacher of the Year Award possible way to engage with teacher further.

- Hosting Fraud Summits in September, Rep Downing Elder Fraud Summit (possible name)
 - Sept 23-24 in Missoula
 - Sept 25-26 in Billings
 - Shoutout to Tim for presenting
 - Deb working to find Missoula location
 - Hoping to have some really key speakers, around 100 attendees
 - Focus on "now what"
 - Life cycle of an APS referral
 - Discussion about various scams, legislative initiatives (e.g HB 743)

Member updates

- Eychner: just got magazine out with updates and opportunities for advertising,
 Montanabankers.com. Also working with advertising agency out of Missoula had BBER report that shows all the ways that bankers individually give back to the community.
- Tangen: bills are a success, on the topic of understanding an APS referral, they just digitized the APS 101 training. On website, also did rebrand and updated brochure.
- Trujillo: hired new financial educator
- Harper: accepted position as Deputy Director of his company, eager to play a bigger role in the state. Still liaison for network at Housing Assistance Fund program.
- Krieger: Federal Reserve Bank has a pause on most outreach activities temporarily while
 leadership makes decisions related to several of the current executive orders since the Federal
 Reserve system is not a govt agency but tries to align with the Board of Governors who is a
 government agency since they are a governing agency for the Fed.
- Ayers: has contracted with new resource, Bonsai, increasing accessibility with multiple languages offered.
- Newman: No update. Continuing to be optimistic that our HUD affordable housing funds continue to flow to the states.
- Alm: fairly quiet here, not a lot going on in legislature for them. Filed complaint against a bank acting questionably, and was able to get the woman out of her loan.
- Schieffer: already shared a lot from MCEE. Happy it's transmittal week!
- Casper: on top of being a financial counselor, also a master trainer in credit. Has been wanting
 to get frontline staff more trained on credit, and got the go-ahead so she's launching training
 for them.
- Kiernan: successfully completed merger into mPactPro (new CRM) hired an education coordinator/counselor. Holding on third counselor until we know more about federal funds.
 Daughter's EP dropped!
- Summers: some big things at legislature at least three bills are moving from one side to the
 other. Hoping for at least a small relief in property taxes. Medicaid expansion has been huge,
 as has rural hospital legislation. Lots of fear and anxiety around social security telling folks to
 not panic, find out all the information first and make decisions based on that. Not seeing
 evidence that social security is going to get hit.

- Randel: got all reports in! Try to create professional development for teachers. Opening a
 training in August to all teachers, August Jump Start Series. Wants to do one on financial
 literacy for the teacher.
- Sandru: loving retirement. Appointed ranch cook and is making the BEST homemade rolls.
- Huff: invited into the personal finance class in Shields Valley HS. As she was teaching, a
 teacher came in to hang out and then had two other teachers reach out to connect, so now
 going to two more classes next week. Working actively to engage active military and veteran
 populations have some meetings with organization in DC to do some specific outreach to
 that population. Also ramping up World Elder Abuse Day in June.
